Please note that if you send originals by mail, you must retain a set of originals for your visa interview at a US Embassy or US Consulate in your home country. The originals sent to Manchester Community College will not be returned.

All documentation must be dated within six months of the date of initial enrollment at MCC. A more current version may be requested by MCC to verify funding. MCC has provided you with an estimate of the annual education and living costs for international students. You must document financial support equal to or greater than this amount. Tuition and fees estimates, as well as cost of living expenses, are subject to change without notice and will usually increase each year. Students must be prepared to meet these increases.
